Faith Foundation works with the philosophy to promote healthy lifestyle away from addiction and addictive behaviours for more than 17 years now. The organisation works at micro and macro level in community as well as influencing policy decisions at state and the national level. Amongst the various projects and initiatives, the organisation works on Deaddiction Rehabilitation, Tobacco Control, Care & Support for PLHIV (People living with HIV/AIDS), Quality education for urban slum children, Life Skill Development for Adolescent, projects as part of Corporate Social Responsibility (CSR).

The organization has been instrumental in Tobacco Control in the state by launching the Yellow Line Campaign (YLC) in all the 33 Districts of the state of Gujarat along with State Tobacco Control Cell (STCC) & District Tobacco Control Cell, Health Department, Govt. of Gujarat striving for stricter implementation of COTPA 2003. The organization trains about 3000 students every year on healthy lifestyle and inspires to live Addiction Free Lifestyle. Faith Foundation has been instrumental in the ban on Hookah Bars, E- Cigarettes in Vadodara followed by Ahmedabad and other places across India. the Organization had collected 5,000 signatures from various schools to support the Ban of E-cigarettes Bill. The organisation in collaboration with various government departments namely the Education Dept, Police Dept, Food & Drug, Information bureau etc. at the district level has initiated unique campaigns like the Tobacco/Smokefree Village/Panchayat, Tobacco Free Educational Institute (ToFEI) & Tobacco Free Workplaces etc.

Rehabilitation Centre is widely recognized as one of the most effective inpatient drug and alcohol rehabilitation centres in Vadodara, Gujarat. We offer treatments and holistic healing to create a unique recovery experience for individuals struggling with alcohol, drug and other addictions.

The organization provides legal services in civil and criminal matters for those poor and marginalized people who cannot afford the services of a lawyer in any Court, Tribunal.

Section- A)	Sale of tobacco products to/by minors	Fine upto rs 200
Section- B)	Sale of tobacco products within 100 yards of any educational institute.	
Section 7,8,9	Mandatory display of specified health warnings on all tobacco product packs.	<p><b>Producer or Manufacturer</b></p> <p>first offense : Fine upto rs 5000 or imprisonment of 2 years or both Subsequent offense fine upto rs 10000 and imprisonment upto 5 years</p> <p><b>Seller or Distributor:</b></p> <p>first offense: fine upto rs 1000 or imprisonment upto 1 year or both Subsequent offense fine upto rs 3000 and imprisonment upto 2 years</p>
